Ingestion: No specific first aid measures are required. Do not induce vomiting. As a precaution, get medical advice.

Inhalation: No specific first aid measures are required. If exposed to excessive levels of material in the air, move the exposed person to fresh air. Get medical attention if coughing or respiratory discomfort occurs. **Note to Physicians:** In an accident involving high-pressure equipment, this product may be injected under the skin. Container Warnings: Container is not designed to contain pressure. Do not use pressure to empty container or it may rupture with explosive force.
